There is already not enough parking at the parade of shops on Wrotham road.

It is a devastation to the nature of the green village and the loss of more arable fields that is used to grow produce to feed the country.

Once the fields are lost they can not be regained. And a loss for nature and the environment, It is devastation to the farming community overall, and industries and local economy.

This is a disgusting nature of urban sprawl within the Garden of England, with too much of. It being concreted over. There are many brownfield sites within Gravesham, that have planning permission that have not been optioned. These should be forced through before corporate greed when the community do not want this.

This construction will produce a dramatic increase in pollution, noise, traffic, a

detriment with live in the area with lack of facilities such as primary school places, doctors, parking at the shops.

My children can currently go for walks within the footpaths across the fields, embracing nature, which if this plan is accepted along with the other current proposals in the area, will be lost due to the building works and housing estates. Not enough children get to experience nature and this will exscperate this issue.

I fear for the safety for my children when waking with the increased number of cars along with the decreased opportunity of the reduction of footpaths across fields

Natural habitats of many wild animals will be lost, as defined by the NPPF, such as veteran trees or woodland, when it is concreted over.

This field does flood during heavy rain. Where will this water go? The plans for drainage is inadequate

The scale of the development does not take into account enough parking for the residents and visitors.

The planned housing estate will rob the existing neighbours with privacy as it will overlook them.

At the moment there is little light pollution at night and you can see the stars. This planning application will increase the light pollution and rob the neighbourhood the of this gift of seeing and enjoying the nights sky.

Public transport can not handle the increase. There is a barely existent bus service through Meopham, with the school buses already being very busy and don't even serve the secondary schools in Northfleet.

The trains are on a line to Victoria, and while busy during peak times, are fairly infrequent and go to a less desirable part of London for commuters. And this will increase the amount of misery of the commuters will. Less space on the trains and more scramble for parking at the station.
