- dressing back stone will have little impact on the special interest of the listed structure (tooling will match the existing detailing) in order to retain the extant character and appearance of the historic masonry chamber
- the dressing back of the masonry will preserve the functionality & operational use of the historic lock, alleviating further impact damage
- much of the time the dressed back masonry will be unseen (submerged when lock is full)
- swapping of pattern boards on the ground paddle boxes is a reversible detail and will prevent water ingress on the timber elements
