Comments:	<p>I strongly object to the planning application 20250992 to build 350 new houses. There will be a massive visual impact for the local community with a development of this size and in the heart of the village.</p> <p>The accumulative effect of this and the other planning applications will have a detrimental effect on the local area and Meopham will lose its identity as linear village.</p> <p>The A227 is already a busy road, the proposed access into the new development will be opposite a very busy shopping area, adjacent to Green Lane which is another busy cut through and tight country lane.</p> <p>Even with the proposed additional car park, which is supposed to ease the burden for the customers of the local shops, there will not be enough parking for all these and the vehicles within the new development. There will be an overspill on to the A227 and surrounding roads which in turn will add to congestion and with the heavy traffic flow there will be an increased risk to pedestrians / children and drivers in this area. There will be an increase in delivery and service vehicles which will also add to the congestion and make the area even more dangerous.</p> <p>During school times the A227 is exceptionally busy without any new junctions or pitch points and the increased traffic.</p> <p>The A227 isn't wide enough for additional lanes and the new junction will just add to the congestion associated with the shops, which is already an accident black spot and drivers who park inconsiderately will get worse.</p> <p>The A227 Wrotham Road is already a major cut-through and without the traffic increase with all the new developments and even more so when the lower</p>

Thames crossing is built, the area will not cope with the increased volumes of traffic. Meopham will become more of a rat run than it is now, with increased pollution and impact on the wider environment and wildlife.

This and the surrounding farmland are prime agricultural land and needs to be protected.

The increased population will add additional strain to an already oversubscribed Meopham medical centre where the wait is already at two weeks. The local Darenth Valley hospital is running at overstretched capacity with the new developments around the hospital, Bluewater and Ebbsfleet without this and the other planning applications.

There are only two trains an hour and often only four carriages with commuters standing without the increase in population, both Soul Street and Meopham are not designed for the increase in commuters. There is an unreliable bus service with only one bus an hour with a limited service at the weekend and no service late in the evening.

Housing developments need areas that can sustain them with full infrastructure and services which Meopham lacks in all areas.

The brown fill sites must be looked at before the mass destruction of green belt / farmland are even considered.

The overall impact of this and all the planning applications 20250993, 20251116 and future applications must be taken into consideration and not in isolation, each development will have a massive impact on the local community and the identity of Meopham as village will be lost.

The proposal to build this and the other developments in such close proximity will overwhelm the area.
