Reasons for comment:	
Comments:	<p>The development proposes access for approximately 120 houses, equating to potentially hundreds of vehicles including delivery and service traffic. Longfield Road is narrow, heavily congested during school start and finish times, and regularly used by heavy vehicles accessing the weighbridge at Green Street Green. The addition of any additional access roads onto the existing 50 MPH Longfield Road exacerbates the danger for residents, schoolchildren, and pedestrians.</p> <p>The site is adjacent to Helen Allison School, which caters to pupils with special educational needs. These children are highly sensitive to noise and disruption. Increased traffic, construction activity, and long-term congestion will cause stress, sensory overload, and alarm, severely compromising the wellbeing of vulnerable pupils and the calm environment essential for their education.</p> <p>The cumulative effect of this application, alongside other pending proposals would result in an estimated 1,440 additional vehicles using the A227, a route already functioning as an HGV cut-through and diversion for major roads, frequently gridlocked during incidents or roadworks. Local side roads are wholly inadequate to accommodate further traffic or emergency diversions, and the forthcoming Lower Thames Crossing will exacerbate these pressures.</p> <p>Public transport provision is insufficient, with peak-time rail services from Meopham and Sole Street already overcrowded and bus services unreliable. The</p>

proposed developments would likely increase Meopham's population by one-third, placing unsustainable strain on existing schools, GP surgeries, hospitals and other NHS services. Furthermore, the site comprises productive farmland within the Green Belt, which has not been released for development, and its proximity to a designated Conservation Area raises serious concerns regarding visual and environmental impact.

This proposal represents an unsustainable and harmful form of development. It would irreversibly damage the character of Meopham, compromise highway safety, and place intolerable pressure on infrastructure and public services. The cumulative impact of this and other pending applications cannot be ignored; together, they would fundamentally alter the scale and nature of the local area.

The Green Belt designation exists to prevent precisely this type of encroachment, and no exceptional circumstances have been demonstrated to justify its release.

For these reasons, application should be refused in its entirety.
