Description

The existing use of the property known as 73 Beaumont Drive has been in residential use for more than four years and therefore falls within Use Class C3(a) of the Use Classes Order 1987 (as amended) and the proposal to change this to a children's home for occupation by 2 children and provision of 24hr care by staff members on a shift pattern falls within Use Class C2 of the same Order. The property is intended to be registered with Ofsted as a Children's Home, providing one placement for 2 children between the ages of 10 and 17 years old. The Children's Home will be managed by DMC Consulting Services Ltd, a specialist provider of residential care services for young people. The Children's Home will be staffed at appropriate ratios based on the assessed needs and risks of the youngpersons placed in the Home. There will be trained staff present at the Home 24 hours a day, 365 days a year, working in shift patterns to ensure continuous supervision and care for the children. The young persons placed in the Home by the Local Authority will never be left unsupervised. No material changes or alterations are required to the property, as it is already fit for use as a Children's Home. However, it is important to note that the carers will not be living on the premises on a full-time basis, but rather the Home will be operated on a shift pattern basis, with staff having other permanent addresses. Change of Use Requirement Given that the Children's Home will not be occupied by a single person or people living together as a family, it cannot be considered to fall within Class C3(a) of the Town and Country Planning (Use Classes) Order 1987 (as amended). Instead, the appropriate planning use class for the proposed Children's Home is Class C2 (Residential Institutions). Therefore, a change of use from the current use class to Class C2 will be required to ensure the proposed use of the property as a Children's Home is lawful and can be provided to Ofsted as part of the registration process. We will work closely with the local planning authority to submit the necessary application and supporting documentation to secure the required change of use. This will include providing details on the operational model, staffing arrangements, and demonstration that the proposed use is appropriate and will not have a detrimental impact on the surrounding area. By obtaining the necessary change of use approval, we can ensure that the operation of the Children's Home is compliant with planning regulations and can proceed with the Ofsted registration process.
