Comments:	<p>The A227 cannot cope with current levels of traffic, most of the road is unlit and can be dangerous for cyclists & pedestrians travelling into Gravesend or to Meopham station.</p> <p>The junction of Longfield Road with A227 is already dangerous with many accidents occurring at peak times, usually in the dark.</p> <p>We have bats, owls, newts, shrews, badgers in the area, new housing will destroy their habitat & other wildlife.</p> <p>Brownfield sites in Gravesend should be used first, the old hospital, the Albion development near the canal basin, & the waterside site at Northfleet to name just 3. Im sure there are many others.</p> <p>We have no research / forecasting from the Highways Agency as to how Meopham will cope with the increased traffic from the lower thames crossing & the new developments at Wrotham / Borough Green.</p> <p>Meopham station trains are already at capacity during rush hour, standing room only.</p> <p>The Doctors cannot cope with current levels of population, trying to get an appointment unless you are elderly is difficult. They cannot cope with more patients, nor is their carpark sufficient to handle current volume.</p> <p>Water pressure is already an issue, more houses will make this worse.</p> <p>Getting to an appointment at Darenth Valley Hospital is extremely difficult. If you can actually get near to the hospital, you then have to wait 1 car out, 1 car in to get into the carpark. No wonder so many people miss appointments, or walk in an hour late.</p>
