Wrotham road is used as a cut through to the A2/M2 and M20. Longfield road is used as a cut through to the M25...both roads were not built to cope with the increasing amount of traffic. Extra cars added to air and noise pollution. Darent valley hospital already cant cope with patients being increasingly sent to London hospitals and waiting lists getting ever longer. It's almost impossible to get a Drs appointment as it is. They cant cope with more patients. All local schools already have waiting lists with local children increasingly having to travel further to go to school when they should be able to go to their local school..where will the extra children go to school and where will the jobs for the patent come from? The local shops have insufficient parking and even with the new road layout I have witnessed 3 accidents with cars trying to pull out in the last few months.
