Pulling onto Wrotham road from a side road is next to impossible some mornings as an increasing amount of traffic adds to the chaos but using it as short cut to the M20,M25 A2 and M2, this will only increase dramatically when the lower Thames crossing goes ahead. Accidents from cars pulling out from the parade of shops ids a regular occurance now, ive witnessed 3 in the last month, despite the new traffic layout line of site is impossible and you take your life in your hands everytime you try. With the addition of exits onto Wrotham road or any adjoining roads its only a matter of time before someone is killed. Pedestrians have it even worse. Parents with young children trying to cross into traffic and teenagers trying to run between cars as nothing stops and when there's a space cars speed to fill it. Cars are parked ileagally all around that area and the council have said they don't have the staff to patrol it. All local schools are full with waiting lists, where are more children supposed to go...the answer is further afield adding more cars to the roads!!... local Dr practices are full...it can take weeks to get an appointment as it is, this time will only increase with an increased population. Our local hospital cant cope with the local population and with hundereds of more homes being built next door to it waiting times for appointments, which are already years long, even for urgent appointments will only get longer with more patients having to be sent further afield for just regular treatment.

We choose to live in a village not a town for the way of life, the community, the countryside itself. Thousands of forms of wildlife will loose their homes. Our children learn about these things by being able to go outside and see it for themselves. Don't take that away from them and future generations. We have a

sense of community here, we look out for eachother, we feel safe when we leave our homes. Many elderly people live here and enjoy an outdoors lifestyle, don't take that way from all of us.
