Comments:	<p>Dear Sirs.</p> <p>It is with a strong sense of concern for the area around Camer that I strongly object to this proposed development. The A227 from Wrotham, to the A2 is under so much strain at the moment. This development, could see somewhere in the region of 720 more vehicles on the road both in the morning and evening commuting to and from work. The junction at the moment where the Longfield Rd joins the A227 is often at a grid lock sittuation, especially if there is a problem on one of the major trunk roads, such as the M20, or the A2. All along the A227 there are very vulnerable points, where the inrease in traffic due to construction, and the resulting commuting traffic, has the strong potential to make the area a no go aerae at certain times of the day, and put childrens lives at risk, by the Meopham School, and the Schools in Longfield Rd.</p> <p>If another 350 homes are built in this area, by my assumption, this could result in another 700 cars accessing and egressing the estate every day, and possibly another 1050 people needing medical facilities locally, if there were 3 people per household. How are the extra places for these people going to be found ? The current excellent medical facililties at Meopham Medical Centre surely would implode under the strain !</p> <p>Another very important issue will be the removal of the area from food production, or is the council in favour of making the UK more dependant on other countries around the world for accessing food. Obviously terrorism is a huge concern, but equally food security should be viewed with the same gravitas. I can't imagine a Britain being held to ransom by a third country, with whom we</p>

would be reliant on. Once agricultural land is taken away from food production, it will never be returned, be careful what you wish for !

The parade of shops is indeed a very vulnerable traffic hazard at the moment, with the resulting construction traffic, then the traffic movements from the residents will make the possibility of a serious accident, a when ? not an if !

I will in conclusion appeal to your loyalty to the good citizens of Meopham and the surrounding villages to refuse this planning application.
