However they can't guarantee my house and those of my neighbours will not flood, so if you let them build above an existing flood problem, you know that you are adding to the problem, which has already happened. Our neighbours were unable to live in their own home for many months in 2019 when their home was flooded.</p> <p>Despite being told being told by Esquire's representative that rainfall has been calculated by people much cleverer than him or me, I do not believe this is not possible as we live on clay which doesn't drain, and we will be getting all of their surface water. Complete fantasy.</p> <p>Once their calculations prove to be wrong, who will be to blame when our houses are flooded and our house prices are reduced. Thank you very much.
