	<p>Wildlife</p> <p>We have beautiful fields full of wonderful wildlife. The impact of this housing on the wildlife, ie badgers, hedgehogs, owls, bats (protected species) would be devastating. We should be protecting our wildlife not making it extinct due to housing.</p>
