The proposal is for a change of use from residential dwelling to a children's care home at 19 The Fairway, Gravesend, with minimal external works. The total site area is well below 0.5 hectares, and the development does not include significant alterations impacting biodiversity. It therefore qualifies for the de minimis exemption from the biodiversity net gain requirement. While the impact on biodiversity is minimal, we are committed to providing minor on-site enhancements such as bird boxes and native planting in the garden area to contribute positively to local biodiversity. These measures will support a proportionate biodiversity net gain in line with national guidance.
