| Comments: | <p>I object to Planning Application 20250992.</p> <p>The scale of this development would place an unsustainable strain on local infrastructure and public services. GP surgeries and wider NHS services are already overstretched, local schools and early years provision are heavily utilised, and emergency services operate within an area constrained by narrow and congested roads. When combined with other major housing proposals in Meopham, the village could see a population increase of up to one third, which is not supported by existing service capacity.</p> <p>Public transport provision is inadequate to support development of this size. Peak-time rail services from Meopham and Sole Street are already overcrowded, and local bus services are limited and unreliable. As a result, future residents would be heavily reliant on private cars.</p> <p>The development would generate approximately 700 additional vehicles using the A227 near Green Lane and a busy parade of shops that is already a known accident hotspot. Existing congestion, on-street parking near schools and nurseries, and narrow pinch points near The George Inn would be significantly worsened, increasing risks to road safety.</p> <p>When considered cumulatively with other large developments in the area, the</p> |
